Citing words from the Rigveda which mean "May your intentions be the same, may your hearts be united. The 73<sup>rd</sup> Constitutional Amendment Act of 1992 formalized the Panchayati Raj system, providing a nationwide framework for rural self-governance. While the fundamental structure remains consistent across India, each state implements the system with variations tailored to regional requirements and administrative setups.

With the majority of India's population residing in rural areas, the Village Panchayat system is crucial for effective management and advancement of rural regions. It serves as the cornerstone of local self-government, providing democratic governance at the grassroots level. The Gram Panchayat's jurisdiction encompasses the village's overall development, welfare, and efficient operation.

The Model Governance Code for Meetings of Gram Panchayats, developed by the ICSI, represents a significant step towards enhancing Indian local self-governance. It aims to standardize procedures for Gram Panchayat meetings, improve operational efficiency and increase Gram Panchayats' effectiveness, accountability, and transparency. Better policy execution, improved rural development, and heightened public confidence in local self-government are all facilitated by village-level governance improvements.
