## **PREFACE**

The concept of Oppression and Mismanagement and its prevention dates back to the 18th Century. In the International scene, the case of *Foss v Harbottle* became the watershed moment that paved the way for development of this concept; while in India, statutory recognition was granted by the 1951 Amendment Act to Indian Companies Act, 1913 where after elaborative provisions were placed in the Companies Act, 1956. Needless to say, the Companies Act, 2013, too followed suit.

Apart from the legislative developments, the Judiciary through its various arms too has played a key role by giving more clarity over these principles in their judgements. The preliminary authority of Company Law Board under the Companies Act, 1956 was transferred to the National Company Law Tribunal under the Companies Act, 2013.

Given the longstanding nature of the concept and its altering dynamics it is significant that an attempt is made to understand the evolution of law in the O&M perspective through the lens of Judicial Pronouncements made over the years.

Keeping in the view the opportunities available for practicing professionals in the arena, the ICSI is bringing out a publication titled "Master Guide for Prevention of Oppression and Mismanagement (NCLT Practice & Judicial Pronouncements)".
